## CEO LETTER

## Dear PATH Intl. Members, Supporters and Friends

The 2019-2020 fiscal year experienced by PATH Intl., the EAS industry and each and every member was certainly one for the record books. In fact there aren't enough over-used adjectives to fully describe the impact of the COVID-19 pandemic. I prefer instead to focus on the positive adjectives that reflect what we saw from our industry from the first time we heard the words Corona Virus until today. Words like **generosity**, **collaboration**, **resilience**, **creativity** and **resourcefulness** all reflect what we saw at every level from PATH Intl. Members. While survey work showed a majority of centers were closed at least for a while, the PATH Intl. Board of Trustees, Credentialing Council and Staff also remained nimble providing information and resources for members while safeguarding the organization's finances in order to continue to secure and provide additional benefits and quality education to members. In recognition of the degree by which all were impacted in varying degrees, the association extended deadlines and payment options in credentialing and accreditation processes and remained flexible in relation to some geographic areas being open to events while other areas were on complete lockdown.

The surveys also told us that many facilities and jobs were negatively impacted, and we all worried about the collective future. Fortunately, most reported the effects being only temporary, and the resourcefulness of the incredible people in this industry shone bright. Before we knew it centers were conducting tele-health and other sessions. Drive-through galas were taking place and sessions incorporated lessons into student school days. We were blown away but not surprised by the resiliency of all.

Thankfully it wasn't all bad news! 2020 saw the culmination of the immense task laid before the optimal terminology workgroup and task force. The recommendations were released and *Optimal Terminology for Services That Incorporate Horses to Benefit People: A Consensus Document* was published in the JACM - Paradigm, Practice and Policy Advancing Integrative Health (The Journal of Alternative and Complementary Medicine). Region leadership teams used Zoom to connect with more members than ever for networking and region conferences. Some things evolved better because of the pandemic! It is for all these reasons I remain optimistic for our association and the industry.

Thanks to prudent budget management and a sharp focus on priorities, the financial state of the organization remains strong. PATH Intl. will continue working for its members to advocate for the industry and provide the tools centers, instructors and others need to run their businesses with operational excellence and deliver effective and safe services for their participants. I'd like to thank PATH Intl. Board President Sue Becklenberg for her tireless energy and commitment to the mission, and thanks to the staff who have managed to keep the wheels turning with great efficiency while shifting to a mostly remote situation.

I thank you, too, dear reader for walking this journey together! The following pages will give you a snapshot of association highlights and finances for 2019-2020. Read them in good health.

## **PROGRAMS & EDUCATION**

## **Education and Conferences**

The PATH International Conference and Annual Meeting held in Denver, CO November 8 – 11, 2019 was a wonderful celebration of the association's 50th anniversary. **Over 650 people** came together to learn, network and celebrate. **Nearly 200 people attended the 50th anniversary celebration** where PATH Intl.'s past, present and future were commemorated including bringing together past PATH Intl. CEOs and board presidents. The awards luncheon was a highlight with the honoring of the national award winners and keynote presentation by Jaycee Dugard.

We were fortunate to be able to hold **four in-person region conferences in the 2019-2020 fiscal year**. Region 5 and region 8 were held in 2019 and region 7 and region 3 in early 2020 before the pandemic shut down the country, causing the remaining region conferences to be canceled.

The virtual conference held May 7–8, 2020 saw a huge jump in registration to **nearly 400 people** as virtual education and learning became a new reality for many. The virtual conference provided quality CEUs and opportunities for live Q & A with presenters.

July of 2019 saw the release of the updated *PATH Intl. Instructor Education Guide*. The new *PATH Intl. Instructor Education Guide* is a handbook for novice and experienced therapeutic horsemanship professionals and to date has **sold over 1,000 copies**.

## Credentialing

The trek to independent accreditation of the PATH Intl. Certified Therapeutic Riding Instructor® (CTRI) Certification continued in 2019-2020. The PATH Intl. CTRI certification program was officially launched October 1, 2019. A total of 24 applications were submitted, and two candidates successfully completed the certification process between October 1, 2019, and June 30, 2020. PATH Intl. Registered Therapeutic Riding Instructors continued to participate in the process to transition to the new CTRI credential. By the end of June 2020, **a total of 1,190 instructors had transitioned**.

The global pandemic had significant impacts on credentialing. In-person events and the number of newly certified instructors were nearly half of the historical average. PATH Intl. is proud of the resilience exhibited by our members, certified professionals and instructors in training and their mentors during the pandemic.

## MEMBERSHIP

## Membership

On July 1, 2019 PATH Intl. launched the new tiered membership structure. The new levels of membership—participating, professional and professional plus—allowed members to select the benefit package that best fit with their needs and financial situation. From member feedback, two of the membership levels include free access to the large library of PATH Intl. conference and webinar recordings. In line with the need in 2020 for virtual education, 3,961 hours of CEUs were accessed as part of this new member benefit.

With the accreditation of the PATH Intl. Certified Therapeutic Riding Instructor Certification, **membership will no longer be required to become certified per the NCCA standards** and as expected, there was a 22% decrease in individual member numbers.

In the 2019-2020 fiscal year there were **nine newly accredited centers** and **36 centers who reaccredited** before accreditation site visits were put on hiatus due to the pandemic.

## **Veterans Programs**

The ongoing partnership with Wounded Warrior Project helped 53 PATH Intl. Premier Accredited Centers provide **1,136 sessions to 390 WWP alumni—totaling \$113,600 in reimbursement** to the centers. After March 2020 the numbers of alumni served was impacted by the center's ability to provide in-person services due to the pandemic.

PATH Intl. was not awarded the United States Department of Veterans Affairs Adaptive Sports Grant for the 2019-2020 grant cycle but will continue its efforts and apply for the next grant cycle year.

## St. Andrews Wirrshi MARKETING & COMMUNICATION

Communications to members and industry stakeholders became even more important this year as circling the industry wagons was necessary to defend against the impact of the pandemic. Members were willing to share everything from protocols to policies, hand sanitizing station designs to reopening plans. The generosity of thought and community was humbling and strengthened bonds across the United States and the world as folks in China were the first to share what their centers achieved as the pandemic took hold.

Through survey work PATH Intl. kept abreast of the pandemic's impact on member centers and PACs. **The association delivered over 30 COVID-19 bulletins and webinars specific to the pandemic** with the purpose of keeping all safe and functioning. The COVID-19 resources area on the PATH Intl. website was overflowing with impactful resources.

While it was not the year for traditional outreach, the association managed to maintain outside-the-industry marketing presence including print and digital trade advertising for the PATH Intl. CTRI® Study Guide and PATH Intl. Instructor Education Guide as well as publicity for the organization through sponsor channels.

## Website


Google Adwords Grant ads continue to drive awareness and web traffic. Even as the pandemic marched on, we were able to reach the public at a high volume. **PATH Intl. ads reached 178,848 public impressions** and **23,681 of those individuals clicked through** to the PATH Intl. website to learn more about the association, its offerings, centers and equine-assisted services in general. In the 2019-2020 fiscal year, the website had **184,093 unique viewers.** The pageviews was almost 900,000. An interesting number is how many people visit the website on any given day. In this fiscal year, **the average active users is 715**.

The website pages visited include certifications (including ES and CTRI), which again topped the list of most visited pages. Join Now, which had broken the top 10 the year before, dropped out. Other pages in the Top 10 were Locate My Region, Centers, Job Center, Membership and My Instructor Membership.

## **Email Communications**

PATH Intl. continues to use Constant Contact to send information to its members. In the 2019-2020 fiscal year, **PATH Intl. sent out 303 eblasts**. As everyone was beginning to feel the impact of the COVID-19 pandemic, PATH Intl., demonstrating once again its leadership in the industry, began on March 17 to send out COVID-19 Bulletins, giving members information on the virus and how to navigate through what that could mean for centers and individual members. From March 17 to June 30, 2020, 24 eblasts were sent, with an **average open rate of 47%**. One member said, "The PATH Intl. newsletters have been an EXCELLENT source of comfort during this turbulent time." Another member said, "This was extremely helpful information especially for our little center. Thank you so much for putting this out!" Finally, "It is nice to know that our professional organization of PATH Intl. is recognizing the impact and evaluating how they can support centers, many of which may be facing serious financial difficulties and possibly permanent closures."

Our average open rate is **12% higher than the industry average** of 22%, and the **click rate is 12%** — 10% higher than the industry average of 2%. Our members are engaged!



## **Social Media**

Facebook is still the most forward-facing social media channel of the association, with **17,054 followers**. The post with the most likes and shares was a Charlie Mackesy "horse and boy" illustration with an uplifting message of hope. We try to balance informational and inspirational posts, but it is clear that the most engagement comes from the inspirational posts.

Other social media channels include **PATH International Equine Services for Heroes Facebook page with 2,786 followers**; **Twitter with 1,984**; **LinkedIn with 1,785**; and **Instagram with 2,095**. LinkedIn continues to be used to present the professional face of the association and has been used to connect with webinar and conference presenters as well as recruiting for board members.


