- Committee approved for the candidates at this event to be tested via role-playing for the non-traditional mount/dismount requirement. The alternate mount/dismount should be the same for both candidates and be adjacent to one of the riding lessons.
- Committee discussed concerns about host sites hosting the Advanced Certification events if they cannot provide the appropriate riders for testing. Amanda will start reminding host sites of this requirement (and the new lungeing criteria) ahead of time. Melissa/Bret will communicate with Advanced Faculty/Evaluators about the lungeing criteria changes and the non-traditional mount requirements to be sure the host sites are aware and prepared ahead of time.
