8:30 – 9:30 am **A1, How to Run Your Center Like a Business and Still Keep the Heart Part 1 - Kathy Alm CE**

Do you think of the service you provide as a business or is it a service fueled by passion and giving back to the community? Fortunately, these descriptions are not mutually exclusive. Most of us join this field because of our passion for equine-assisted activities and therapies. In researching the challenge of sustainability for centers, one of the top issues consistently raised was business knowledge. In order to be sustainable, it is important to not only follow the passion and mission, but approach service delivery from a business perspective. Join PATH Intl. CEO, Kathy Alm as she explores the steps to running your center in a sustainable manner while remaining focused on mission delivery and the "heart" of your organization.

**Kathy Alm** began her service as Chief Executive Officer of the Professional Association of Therapeutic Horsemanship, International (PATH Intl.) in August 2014. For the previous 16 years she served as Executive Director of Little Bit Therapeutic Riding Center in Woodinville, WA. She grew the previously grass roots organization from a \$280,000 annual operating budget to a professional \$2.1 million organization. Kathy served as PATH Intl.'s board president in the 2010–2012 term, first joining the board of trustees in 2005. She has facilitated numerous workshops and presentations on board, staff, fundraising and strategic planning and enjoys the opportunity to share her experience as well as learn from others. Her dedication to the field of Equine Assisted Activities and Therapies spans over 19 years with a passion that was ignited the moment she walked through the door at her first therapeutic riding center.

Specific Hurdles and Challenges that have been identified in previous surveys in the USA provide the base for this study. The continued investigation through 2018 provides insight into Barriers that can positively and negatively affect EAAT currently and in the future. The intended outcome is to help guide decisions in the EAAT field.

**Pebbles Turbeville** is an associate professor and chair of the Equine Studies Department at St. Andrews University. She currently working on her Doctorate in Sport Management and received her Master's degree in Recreation from NC State and BA in Physical Education from Columbia College. Pebbles is a PATH Intl. Advanced instructor, Mentor Faculty, Associate Faculty for the PATH Intl. Advanced certification and Lead Faculty for Registered On-Site Workshop/Certification. She served on the NARHA Board and served on several committees for PATH Intl. Pebbles has taught over 100 college students in the field of therapeutic horsemanship at St. Andrews. She has presented at different national and regional conferences on several topics in the therapeutic horsemanship field. One of her favorite hobbies is photography. Pebbles has been published regionally, nationally and internationally in American Horse, Dressage Today, Horse Illustrated, Strides, Horse of Kings, Stable Mates, RDA New South Wales postcards and Southeast Equine Cover.

The TRAAC (therapeutic riding assessment for adults and children) is a tool developed to facilitate a point scale for rating student's strengths and areas of needs as assessed during the riding session. It is a numerical scale that can document present skill levels of engagement and allow for notation of progress in the different areas of riding performance.

**Cheryl H. Coughlin** has been involved with therapeutic riding since the age of 18. She was executive director of the premier center– Hawthorne Riding Centre. She is actively involved with the Therapeutic Association of Virginia, holding official positions on the board as well as chairing the national conference in 1994. She continues to sustain her interest moving from an active participate professional in the therapeutic riding industry to a research based focus from an occupational therapist and therapeutic riding instructor perspective.

Debbie teaches therapeutic horsemanship part time at Storybook Farm in Opelika, AL, a PATH Intl. member center. She is a PATH Intl. Registered Instructor, Mentor and Site Visitor.

This presentation highlights one piece of the puzzle that is often overlooked: the vagal tone and how it can affect and be affected by the patient's core muscle activity in equine assisted activities. Through anatomy review, videotaped equine movement observation and experiential learning (Awareness Through Movement lesson), this presentation will develop the instructors and volunteer's ability to assess their rider's vagal tone and to understand the degree to which it interacts with their rider's core muscles' activity and therefore posture.

**Catherine Wycoff**, PT, DPT, HPCS graduated from Liege University (Belgium) in 1989 with a B.S. in Physical Therapy, and from Des Moines University (Des Moines, IA) with a Doctorate in Physical Therapy in 2008. She is a certified Feldenkrais, Myofascial Release, Kinesiotaping and Anat Baniel Method (for Children) practitioner. She is a Hippotherapy Clinical Specialist and a PATH Intl registered Therapeutic Riding Instructor. She recently graduated from the University of Tennessee's Certified Equine Rehabilitation Specialist program. Catherine is a lifelong horse lover and rider, with experience competing in jumping and training in dressage and driving. She has been incorporating hippotherapy in her private Physical Therapy practice in northern Virginia since 2007. She is the owner of 3 horses who are involved in hippotherapy, therapeutic riding and therapeutic driving. She recently started providing physical therapy treatment for horses, specializing in rescue horses and those involved in therapeutic riding/driving and hippotherapy. She is also an ergonomics consultant for the World Bank in Washington, DC, and, as such, conducts regular group presentations and trainings both in English and in French for the World Bank staff in Washington, DC and in country offices all over the world.

Session G

8:30 – 10:30 am     **G1, ASD (Autism Spectrum Disorder) Insights: Neurologistics & Stay Calm Strategies - Suellen Hill & Elizabeth Hill DE**

What makes this educational workshop exciting is that Elizabeth is on the autism spectrum and speaks of “her view” as she describes the sensory overload she endures and the coping mechanisms she has learned throughout her life. Her mother, Sue speaks first on the underlying neurophysiology and current research in the field. As a retired physical therapist and professor of neurology, Sue presents in a manner that is upbeat, visual, and inter-active. Elizabeth then follows with her “Stay Calm” strategies relevant to working with clients on the autism spectrum. The daughter/mother dynamic and comfort with the subject allow the audience to become engaged with their own questions, thoughts, and tips for working with those on the autism spectrum.

**Suellen Hill**, PT received her degree from West Virginia University in 1972. For over 45 years, she practiced physical therapy in all settings: acute care, skilled nursing, rehabilitation, home health, early intervention, and education. Neurology has always been an interest of Sue’s, but the interest turned to a desperate need to find answers when her fourth child, Elizabeth, was diagnosed as mentally retarded at age six. An Assistant Professor of Physical Therapy at Pierpont Community & Technical College for 17 years, Suellen was titled Faculty Emerita upon her retirement in recognition of her service to the Physical Therapist Assistant Program. Sue has the ability to take complicated neurological concepts and present them in a manner which allows her listeners to utilize “neurologistics” in a variety of settings. Of interest to those who enjoy horses, Sue was the “nanny” for her family’s herd of 28 Appaloosas at Clifton Farms in Shepherdstown, WV.

**Elizabeth Hill** was speaking in complete sentences by the age of one and did not walk until she was two. At age four she could recite word for word the Discovery Channel episodes on Wolves and Whales, and only knew two colors, pink and blue. Finally, at age 18, the diagnosis of Asperger’s Syndrome gave Elizabeth a sense of freedom from the taunts of “retard” she had endured for years, but gave no guidelines as to her next steps. Having grown up with horses, she knew she wanted to help others discover the soothing bond these gentle giants provided. Now at 31, Elizabeth has spent years as a volunteer at “On Eagle’s Wings” under the mentorship of Carole Petitto. By chance, Elizabeth was asked to share her story with Carole’s students at WVU and her mother’s students at Pierpont Community and Technical College. Her rapport with her audience and her comfort with giving her inside view of sensory overload and the challenges she overcomes each day allow Elizabeth to be a strong voice for those on the autism spectrum who cannot speak.

In 2015, BoardSource selected Susan to serve as a Governance Trainer and Susan is a judge for the prestigious Center for Non-Profit Advancement AIM award for best managed nonprofit in DC, MD and VA.

**Laura Pallavicini** is the Executive Director of Riverwood Therapeutic Riding Center. In addition to 30+ years riding and horse experience, Laura brings professional know-how working with foster care families and children/adolescents with severe mental/emotional traumas and behavioral disorders to her position. She is a PATH Intl. Equine Specialist and a PATH Intl. Advanced Instructor.

**Barbara Ford** is the Executive Director of Untamed Spirit and is a Resident in Counseling at Integrative Counseling and Wellness and Untamed Spirit. She also works with a variety of community mental health agencies at the farm. Barbara is a "former" board member of TRAV and holds a Certificate in non-profit management. From 1989 through 2011, she served as Executive Director and Founder of EQUI-KIDS Therapeutic Riding Program. She has received the James Brady Professional Achievement Award and National Volunteer Leadership Award from PATH Intl.

**Carol Young** is Executive Director of Healing Strides of Virginia, an organization she grew over the last ten years coming from \$140k of debt and serving 15 participants to a million-dollar facility that serves almost 200 participants a week in all of the programs combined. Carol is an entrepreneur owning her own business which lends great experience and a working knowledge as a business leader. She has utilized those skills to successfully develop and grow Healing Strides of VA. Carol is a PATH Intl. Mentor at Registered and Advanced Levels, a PATH Intl. Certified Instructor, EAGALA Level II/Advanced Trained Equine Specialist and Certified Life Coach.
